

Privacy notice

Mid-Derbyshire Motor Club Limited respects your privacy and we will only use your information in the way we describe in this notice. When using your information we aim to be fair and transparent, and to follow our obligations under UK data protection laws.

Your information is used for administering club membership, activities and competitions.

Mid-Derbyshire Motor Club Limited is the data controller for the purpose of GDPR and the Data Protection Act 2018. Our club contact for privacy and data is Lee Burgess, and the contact details are chairman@mid-derbyshiremc.co.uk

Collecting your information

We collect your information when you fill in membership application or renewal forms, and competition event entry forms. You can give us your information using paper forms or online forms.

What information do we collect?

We receive, collect and store any information you enter onto our website or provide us in any other way, such as when you complete a purchase or make comments / feedback on our facebook page or forum.

The information you give us may include your contact details (e.g. name, address, telephone number, email address), personal information and identifiers (e.g. membership number, competition licence number), and other information (e.g. vehicle details). When you give us information about another person, such as a child, parent, guardian, or emergency contact, you should let that person know that you have given us the information.

If you are under 18 years old, we will also ask for information from your parent or guardian.

In addition, we collect the Internet Protocol (IP) address used to connect your computer to the Internet and your browsing history. We may use software tools to measure and collect session information, including page response times, length of visits to certain pages, page interaction information, and methods used to browse away from the page.

Using your information

We use your information when you first apply to become a member of Mid-Derbyshire Motor Club Limited and then to administer and renew your club membership, and provide you with member benefits.

We also use your information when you enter club events. For competitions, we will publish some of your information in the programme and the results, which will be in the public domain. Your information is used in these ways to fulfil our contract with you.

We may ask you for emergency contact and next of kin details, which we will only use in an emergency and which is used for a legitimate interest. You should let the contact and next of kin know that you have given this information to us.

We might use your information to send you marketing messages by email, but only if you have agreed that we can do this by giving us your clear consent – and you can change your mind at any time just by letting us know.

We may contact you to notify you regarding your membership, to troubleshoot problems with your membership, to resolve a dispute, send you information, to collect fees or monies owed, to poll your opinions through surveys or questionnaires, to send updates about us or as otherwise necessary to contact you. For these purposes we may contact you via email, telephone, text messages, and post. We will not sell your information to another organisation.

To support your lifetime relationship with motor sport and Mid-Derbyshire Motor Club Limited we may keep your information indefinitely, unless you ask us to delete it.

Sharing your information

We may share your information with Motorsport UK as required by its General Regulations for governing motor sport, with other MUK Registered Clubs, with medical personnel, or any other person if we have to comply with a legal obligation. We may also share your information with service providers, for example to print programmes.

Security for your information

Your information is held securely by us. We have taken all reasonable steps, and have in place appropriate security measures, to protect your information. Your information is not transferred outside the European Economic Area.

How do we store, use, share and disclose website visitors' personal information?

Our website is hosted on the Wix.com platform. Wix.com provides us with the online platform that allows us to provide information about our products and services and to provide other products and services to you. Your data may be stored through Wix.com's data storage, databases and the general Wix.com applications. Wix stores your data on secure servers behind a firewall.

How do we use cookies and other tracking tools?

Cookies are small pieces of data stored on a website visitor's browser, usually used to keep track of their movements and actions on a site. Cookies are implemented in every website built by Wix. Our website uses the following cookies:
