1. ANNOUNCEMENT

Mid-Derbyshire Motor Club Ltd will organize a 12 Car Navigational-Clubmans on The 6th February . Start and finish from The Amber Inn, Furnace Row, Toadhole Furnace, near Oakerthorpe. DE55 7LL (119, 3895 5700)

2. JURISDICTION

The event will be held under the National Competition Rules of Motorsport UK (incorporating the provisions of the International Sporting Code of the FIA) and these Supplementary Regulations.

3. AUTHORISATION

MSUK Permit Number TBC

4. ELIGIBILITY

The event is open to fully elected members of the organizing club and Members of the following clubs: - Coalville Car Club, Eastwood & District Motor Club, Loughborough Car Club, Matlock Motor Club & Carlton & District Motor Club, All competitors must produce a valid club membership card Competitors will be required to produce proof of MOT and ownership of vehicle or owners consent to use the vehicle..

5. CHAMPIONSHIP

The event is a round of the MDMC winter championship.

6. PROGRAMME

Arrival time opens at 19.00 hours and closes at 19.30 hours. Any competitor not signed on 30 minutes before their due start time may be excluded. Car 1 starts at MTC1 at 20.01 hours and from then on at 1-minute intervals.

Vehicles must be self-scrutineered.

7. ROUTE

Map 119 C4 is required. Total mileage will be Approx 50 miles. Smooth White roads may be used. The finish will be at The Amber Hotel

8. TECHNICAL REGULATIONS

All vehicles must comply with the current MSA technical regulations (NCR's) Ch.7 App.2 Art.1-2 (7.2.1-2) and Ch.13 App.15 Art.1 (13.15.1)

9. NOISE

Competitors vehicles must comply with noise as stated in Ch.7 App.8. Art.3 (7.8.3) at the start and during the course of the event. If your vehicle does not comply then you will not be able to start.

10. ENTRIES

Entry forms are on the website. Please print off , fill in and bring with you on the night. If you want to pay on the night, then that's fine but would prefer if you use the bank details below to pay by bank transfer.

14. ROAD BOOK/TIMECARD

Entrants will be supplied with a Road Book/ Timecard at signing on and other points along the route. These documents will provide all the information necessary to enable competitors to comply with Ch.13 2.9 and Ch.13 App.5 Art 2.1 This information may be graded according to Navigators experience.

Give Ways and Stop signs will be treated as Ch.13 App.4 2.3

Competitors will be required to make up lateness at the specified rest halts and/or time make up sections Ch.13 App.5 10.15

Competitors will be identified by rally plates supplied by the organisers to be displayed on the N/S rear window.

15. PENALTIES

Marking and penalties will be applied as per ..Ch.13 App.7 As follows: -

(a) Not reporting or reporting OTL at a Main Time Control		Retired

(c) Not complying with the route card including visiting a control more than once		15 mins

(g) Arrival before due time at the end of a Neutral Section		30 mins

(i) Early arrival at an intermediate Regularity or Regularity control		2 x early minutes or seconds
(j) Breach of any statutory requirement concerning the use of a motor vehicle		30 mins

16. MODIFICATION OF GR'S

All general regulations of the Motorsport UK apply as written, except for the following, which are modified:

Mobile telephones may be carried in the car (for use in breakdown or emergency situations only)

Secret checks may be established to ensure compliance with route instructions, technical regulations, noise and maps used Maximum lateness is 30 minutes

17. INSURANCE

The Club has applied to REIS for a Blanket Cover Note to provide competitors who need Third Party Cover to meet RTA requirements on the Road Sections of this Event. The basic rate for the event (before any loadings with be £22.00. All new applicants wishing to use the scheme must be able to comply with all points of the REIS Declaration: -

Over 19 and held a full licence for at least 6 months

Not more than 1 fault accident in last 3 years

No more than maximum of 6 speeding points on licence

No physical or mental disabilities.

No other material facts to disclose.

If you comply with all points above NO LETTER OF ACCEPTANCE WILL BE REQUIRED.

18. OTHER INFORMATION

Force majeure notwithstanding, the organisers reserve the right to delete or amend penalties at any control or check and/or delete any part of the route from the results, should they deem it fairer to do so. Organisers will enforce this should it become obvious that an incorrect time has been entered onto a timecard. Any notice displayed at the start or on the route bearing an official's signature shall have the same authority as these SR's.

19. NAVIGATION

Route definition will comply with current EMAMC rules.
